

We work in partnership.

We work with businesses to create robust legal frameworks, and train experts to uphold them.

Following our action, the Supreme Court declares the UK Government in breach of clean air laws.

We lodge a first-of-its-kind brief in the US to defend the Environmental Protection Agency's power to regulate carbon emissions. We help draft the new EU Fisheries Law to ensure more sustainable fishing practices.

Ending coal power

There's no doubt: coal power is the biggest contributor to the climate crisis.

We intend to end coal – globally. We block coalfired plants and mines, both planned and existing. We defend communities' rights to protect their homes and ecosystems. We win groundbreaking legal victories that cut coal off from the finance it needs to continue business as usual.

Successful litigation against coal plants costs about €270k per plant in Europe. In Asia alone, we have 400+ plants to stop.

So far, we've:


- Launched 72 legal actions against coal.
- Stopped or shut 48 large coal plants across Europe.
- Forced 15 national governments to move beyond coal.
- Prevented the construction of a huge new coal plant in Poland.
- Forced the owners of the worst carbon emitter in Europe, Belchatow coal plant, to plan its shutdown.
- Challenged the legality of government subsidies to dirty coal companies.

In our sights

We go after the worst-offending industries and institutions where we can have the greatest impacts: coal, plastics, finance, forests, chemicals and much more. We choose strategic targets and actions that set powerful precedents, creating opportunities for others to follow suit.

Wherever we work, and whatever we're tackling, our approach is the same: establish citizens' access to the law, work in local partnership, and use our expertise to strengthen and defend the laws that protect people and planet. 2014

In Gabon, our first-of-its-kind 'forest law bible' enables local communities to protect and preserve the forests they depend on.



Plastics: preventing oil's 'plan B'

Each year, about 335 million tonnes of plastic is produced – equivalent to the combined weight of every human on the planet.

Making a single plastic bottle uses the energy equivalent to filling it a quarter-full of oil. As energy generation moves away from fossil fuels, plastics are fast becoming the biggest driver of oil demand – but we're fighting it.

In Belgium, Europe's largest petrochemical company plans to build a €3 billion plant. We're using the power of the law to shut down construction before it can begin.

We win a second air pollution case against the UK Government in the Supreme Court.

Coming clean about chemicals

60% of all chemicals in production are hazardous to the environment, and 40% to human health.

Behind the scenes, powerful corporations are lobbying hard to block or delay regulation that would prevent contamination of our water, soil and air. We're taking them on. With other NGOs, we secured a radical change: under new law, EU institutions must publish their studies on the safety of chemicals that end up in our food, including pesticides – telling people the truth about their harmful effects.



The future of forests

2015

Since 1990, the world has lost areas of forest equivalent to the size of South Africa.

Forests are a critical piece of the battle against climate change, and home to some of the world's most diverse ecosystems. We're working to protect our forests for generations to come.

We're focused on reducing demand and supply. Less demand means less deforestation: we secure tougher laws and enforcement in countries where illegal timber (and other forest products) end up. We also prevent illegal logging at the source, collaborating with local communities, legal experts and NGOs.



2017

After 10 years, the UN upholds our demand that EU citizens must be able to go to court to protect the environment.

With our input, Ghana passes a landmark forest law. It becomes the blueprint for similar laws in lvory Coast and Republic of Congo.

Cleaner air, liveable cities



Breathing polluted air causes around 400,000 early deaths across the EU each year.

We're working with citizens and organisations to slash illegal air pollution and realise a new vision of cities with people at their heart.

In the UK, ClientEarth has won three major court cases against the government, forcing action to drastically improve air quality. A ban on the sale of petrol and diesel cars from 2030 has been announced in the UK. In Germany, we brought more than 40 cases, forcing a radical shift towards electric. We're helping clean up Krakow's air with wins that have banned domestic burning of solid coal and wood. Now we're working in Belgium, Hungary, Bulgaria and Poland to ensure they follow suit.

In London, the resulting rollout of the Ultra Low Emissions Zone saw a 29% reduction in NOx emissions in its first six months. Environmental funders vote ClientEarth the UK's most effective environmental charity.

Changing terms of business

Scientists warn that we have just 10 years to stop global warming going above 1.5 degrees, beyond which drought, floods and extreme heat will affect hundreds of millions of people worldwide.

Meeting the goals of the Paris Agreement – the first universal, legally binding agreement to keep global warming to well below 2°C – will require radical change in our laws, economies, policies and businesses. But political and corporate will is often too weak or too slow for the task. We're working to ensure governments establish climate laws, plans, policies and targets to meet their commitment to the Agreement. We monitor and challenge the worst-performing countries to slash their emissions.

We're focusing on corporations too, fighting to force companies to be responsible under law for the emissions and climate change they create. We've thwarted the UK's plans to build Europe's largest gas plant and forced BP to pull its multimillion pound greenwashing campaign.

Next, we're cutting off finance to climate-destroying industries. Our influence persuaded the European Investment Bank to end all lending to fossil fuels in 2021. We're pressuring the pension sector to come clean to investors about the extent of their investment in climate-wrecking projects, and we're taking on the banking sector too.



We launch the Clean Air Parents Network, pressuring the UK Government to clean up illegal air pollution. We win our third victory on air pollution in the High Court. The judge praises us as "a valuable monitor" of the UK Government and its inaction. 2019

We win a world-first climate risk case preventing the construction of Europe' last coal-fired power station. Our legal action saves one of Europe's last primeval forests, Poland's Bialowieza, from destruction.

Where to now?

The Australian Government promises \$25m to Torres Strait Islanders after our human rights complaint over climate inaction.

To meet the scale of the challenge before us, we're expanding and scaling up as swiftly as we can.

In Europe:

- Pursuing world-first cases protecting rights to clean air.
- Pressuring finance leaders to align their investments with the Paris Agreement.
- Litigating against governments illegally using pesticides banned in the EU.

Elsewhere:

- Bringing our innovative climate finance strategies to the US, to impact the world's largest financial markets.
- Laying the groundwork to expand our crucial forests work to Brazil.
- Working with the EU, the UN and China to protect biodiversity.
- Post-Brexit, we're shaping the future of UK environmental policy – stronger laws, powerful oversight bodies and a more positive vision of nature's place in our society.

We're taking everything we've learned to Asia:

- Working with national partners on legal interventions across Asia, including in Indonesia, Japan and the Philippines.
- Working to protect forests in Thailand, Laos, Vietnam and Cambodia by securing communities' legal rights to manage them.
- Recruiting our team, building partnerships, and looking to open a new base in the region.

In China:

- Training judges and prosecutors to protect the environment.
- Helping to write and implement tougher environmental laws.
- Promoting greener overseas investments and trade, including the Belt and Road Initiative.
- Improving co-operation between the EU and China on the environment.

We're already using the law to prevent the development of more than 7GW of new coal power capacity in Japan and South Asia.

It's our world. These are our laws. This is our work – join us.
